OPEN WATER HABITATS, INTERTIDAL MUD-FLATS, ROCKY SHORES, SALT PONDS, MARSHES AND SHADED CREEK HABITATS ALL COME TOGETHER TO FORM THE ICONIC BAY THAT DEFINES THE CHARACTER AND COMMUNITY OF THE BAY AREA.

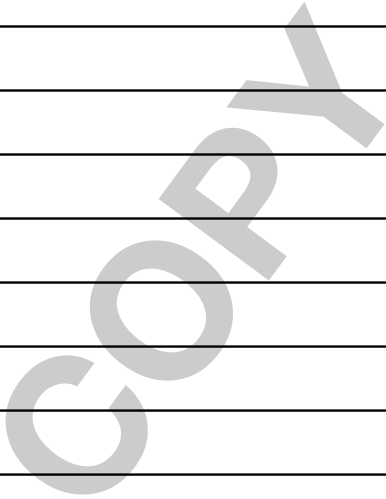
